\*Donation Fee is charged on each donation to the DAF and the tiers are based on cumulative donations over time.

\*\*Annual Fee is incremental at the tier: 50bps on first 1st \$1 million, 35bps on the next \$1 million, 15 bps on the remainder, and is based on the market value of the assets in the DAF. Investment Management Fees are in addition to the fees shown above.
