Short-term technical factors and reported positive earnings surprise also influence investment process.

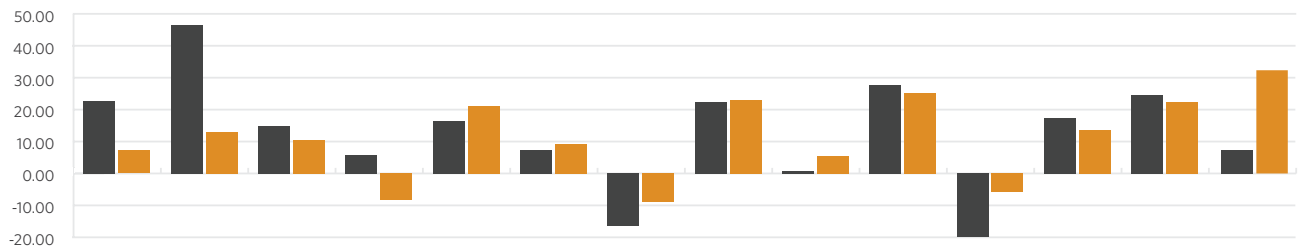
