Identify stocks that have strong earnings growth, earnings reports that beat analysts' expectations and increasing estimates for future earnings.

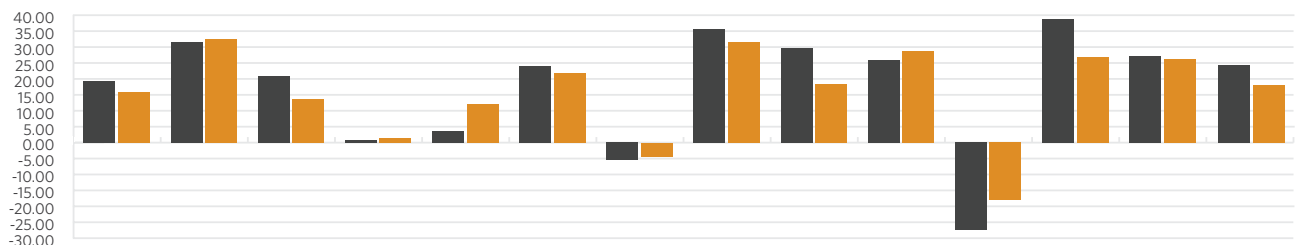
