Calculation of Performance

The Compounded and Annual Performance returns set out below were calculated by taking the actual performance of the accounts following the Income Equity and Growth Equity strategies and combining them on an equal-weighted basis (50% to each strategy). Had an account been following the Canadian Focused strategy in this weighting, the hypothetical returns below set out the performance that could have been achieved over the past measurement periods.

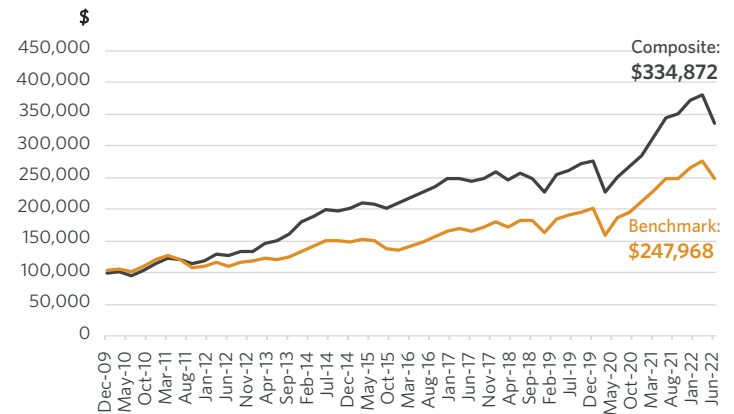

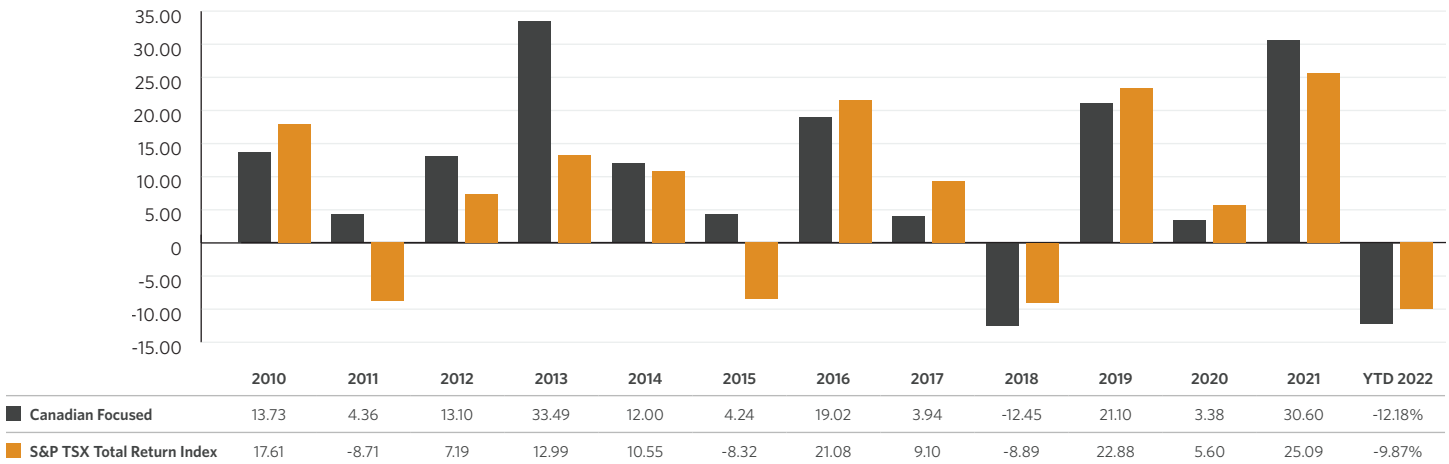
